Virtual - All Lectures and Workshops can all be done virtually using Zoom. No recording of the presentation can be done by the guild without prior written permission.

On-Location – There is a minimum requirement of two events which may be any combination of lectures and workshops. I will be selling merchandise at these events. Please double-check that sales are allowed.

Transportation, Lodging and Meals – Transportation is paid by the guild and includes applicable air fare, rental car fees and/or mileage (round-trip and in-town) at current IRS rate. Air fare is due to speaker upon guild's receiving receipts of speaker's purchase. Lodging is provided by the guild and may be a private room in home or rental lodgings. Meals are provided and/or paid by guild, not to exceed the current IRS per diem rate, after receipts are provided by speaker. In the event of delays or overnight stays due to in bad weather, the guild pays the additional costs.

Deposit - \$150 deposit is required with the signed contract to hold the guild's date/s. It is credited to the event total. If the event/s is canceled 6 months prior the contracted dates, \$100 will be refunded to the guild. If event/s is canceled within 6 months of the contracted dates, no portion of the deposit will be refunded.
